 De Witt I do hereby permit my said wife to have the use of the same cur-
 ring for life but if my said wife should prefer that the said household goods
 and furniture plate linen china and other effects or any part thereof should
 be sold or disposed of I hereby authorize my said husband or the executors or
 the survivors of them to sell and dispose of the same or such part thereof as
 my said wife shall be desirous of selling and I direct that my said husband
 or husband for the time being shall place out and invest the money to be
 arise from any such sale or sales in the public stocks or funds or upon any
 government or real security in England and to and shall stand and be em-
 ployed of the said trust moneys and the stocks funds and securities upon
 which the same may be invested and the survivor's interest and proceeds there-
 of during the life of my said wife upon trust to pay such interest or proceeds
 and proceeds to my said wife and her assigns for ever life and from and
 after the decease of my said wife I give and bequeath the said household
 goods and furniture plate linen china and other effects or such part thereof
 as shall remain unsold as well as the moneys to arise by the sale of
 the same or any part thereof and the stocks funds and securities upon
 which the same may be invested under the aforesaid trusts unto
 and equally between my said three sisters Martha Christiana and Anne
 Ann Griffiths and Jane Griffiths in equal shares and proportions as tenants
 in common and their respective executors administrators and assigns or
 and I declare that my said dear wife shall not be liable or accountable
 for any loss or diminution of the said goods furniture and other effects
 by the reasonable wear and use of the same also I give and bequeath
 all the rest of my personal estate and all my moneys and securities for mo-
 ney and all estates vested in me as mortgages (subject to the payment
 of my debts funeral and testamentary expenses) unto and equally between
 my said three sisters Martha Christiana and Anne Griffiths and Jane
 Griffiths equally to be divided between them share and share alike as ten-
 ants in common and their respective executors administrators and as-
 signs and I appoint my said dear wife my sister Ann Griffiths and
 the said Charles De Witt executors of this my will the witnesses whereof
 have to this my last will and testament signed and subscribed my hand this
 tenth day of February in the year of our Lord one thousand eight hundred
 and forty nine — Thomas Griffiths — signed and authorized by the
 above named Thomas Griffiths as and for his last will and testament
 in the presence of us who in his presence and in the presence of each other
 have subscribed our names as witnesses to the words "Nector of Queens-
 town in the County of Down" and the words "between" and first interlined
 between the first and second lines of the first page of this will — Henry
 Lynn — John Banton — James — Lewis — Lawrence — James — to the Hon. J. Griffiths

Proved at London 3rd May 1841 before the Judge by the oaths
 of Elizabeth Griffiths widow the relict Ann Griffiths daughter the sister and
 Charles De Witt executor the Executors to whom a power was granted
